Department of CADA, Manipur.

Sir,

I am directed to refer to government letter No. 1/61/11-RR(CADA)/DP dated 27th October, 2011 on the above subject. The Full Commission have considered the proposal. The Commission was of the view that it would be unfair and unjust to cut off the line of promotion for Field Assistants possessing B.Sc.(Agri.) by amending the existing method of Recruitment Rules to the post of Assistant Agriculture Officer from 75% by promotion and 25% by direct recruitment to 100% by direct recruitment.

The posts of AAO in the Department of Horticulture and Soil Conservation, Manipur which are similar with the posts under reference in CADA for promotion from Field Assistants possessing B.Sc. (Agri./Horti).

It would be better to fill up the 3(three) posts of Assistant Agriculture Officers, CADA in the ratio of 2/3rd by promotion from Field Assistants possessing B.Sc. (Agri./Horti) and 1/3rd by direct recruitment from B.Sc.(Agri./Horti) degree holders.

The Department will be benefited by new recruits with the latest knowledge in the Agriculture Sector, where new technologies are in need.

2. A copy of the draft Recruitment Rules as approved by the Commission is sent herewith for kind consideration and necessary action.
